JOINT STATUS REPORT

Pursuant to this Court's Order dated April 23, 2024, the parties to the above-captioned case jointly provide the following status report:

1. In light of the Supreme Court's decision in *Collins v. Yellen*, 141 S. Ct. 1761 (2021), the parties jointly propose that Plaintiffs shall have until June 17, 2024 to decide whether to (a) move to amend their complaint in an effort to allege facts that Plaintiffs contend sustain a claim under the Supreme Court's *Collins* decision, or (b) voluntarily dismiss their case with prejudice.

2. The parties also agree that if Plaintiffs move to amend their complaint, Defendants shall be free to make any arguments in opposing that motion, and the agreement to the above schedule shall not prejudice their ability to make those arguments in any way.

3. The parties further note that current FHFA Director Sandra L. Thompson is automatically substituted as a defendant in her official capacity in place of the currently

named defendant, former FHFA Director Mark A. Calabria, in his official capacity, and respectfully request that the caption be updated accordingly. *See* Fed. R. Civ. P. 25(d).
